Notification No. CSR/ 26 /13

It is notified for the information of all concerned that in terms of the provisions of Section 54 of the Calcutta University Act, 1979, (as amended), and, in exercise of his powers under 9(6) of the said Act, the Vice-Chancellor has, by an order dated 11.09.2013, approved *some amendments to the earlier notification notified under Notification No.CSR/17/13 dated 31.07.2013 and Notification No.CSR/39/12 dated 28.09.2012 as laid down hereinunder:*

1. **Amendments to Notification No. CSR/17/13 dated 31.07.2013**

Candidates appearing B.Com. Part-II (Honours) Examination in 2014 for the first time or reappearing as a whole shall have to follow the partially amended Syllabus & partially modified course structure of the B.Com. Honours Course of Studies, vide Notification No.CSR/17/13 dt. 31.07.2013.

Partly qualified back-year Candidates appearing B.Com. Part-II (Honours) Examination in 2014 in failed paper/s shall follow the syllabus and course structure of the B.Com. Honours Course of Studies, laid down under Notification Nos. CSR/89/10 dt.30.06.2010, CSR/98/10 dt. 26.08.2010 and CSR/39/12 dt. 28.09.2012.


2. **Amendments to Notification No. CSR/39/12 dated 01.10.2012**

Clause 16(c) of the above mentioned Notification be read as follows:

A candidate securing 30% marks in at least two Honours Papers in the Part-II Honours Examination but failing to obtain at least 35% marks in aggregate of Honours papers may reappear in all the Honours papers or may reappear in the failed paper/s only, if any, within the stipulated period in order to qualify as Honours candidate . But, he/she shall not be allowed to continue in the 3rd year Honours Class, however, he/she may continue in the 3rd year Class as General Course Candidate and appear at the Part-III General Examination along with the failed papers of Part-I & Part- II Examinations, if any. Such candidate shall have to appear at the Part-II Examination in the Corresponding Papers of 2nd year General Course.

The amended clause shall be effective for the candidates who appear B.Com. Part-II (Honours) Examinations in 2014 and onwards for the first time or reappear as a whole.

Notification No. CSR/ 27 /13

It is notified for the information of all concerned that in terms of the provisions of Section 54 of the Calcutta University Act, 1979, (as amended), and, in exercise of his powers under 9(6) of the said Act, the Vice-Chancellor has, by an order dated 11.09.2013, approved following amendments to the existing regulations (vide Notification Nos.CSR/98/10 dated 26.08.2010, CSR/123/10 dated 19.11.2010 and CSR/22/12 dated 20.06.2012) :

Candidates shall have to clear Part-I, II and III examinations within a total span of 10 (Ten) years from the year of Registration subject to fulfilment of other conditions of the existing regulations, and individual span for clearing Parts-I/II/III examination is removed.

The above will take immediate effect.
