**O R D E R**

Government of India provides full interest-subsidy for the academic sessions 2009-10 onwards, till the scheme remains in operation during the moratorium on educational loans for students with parental family income less than 4.5 lakh annually, from scheduled Banks for pursuing courses of studies in Technical Education and professional streams from recognized institutions of India.

2. In order to ensure that benefits accrue to the eligible students of the States, the Government now designates authorities as hereunder to issue certificates based on income criteria only.

<i>District Level</i>	:	<i>District Magistrate or Additional District Magistrate of the concerned district.</i>
<i>Sub-Divisional Level</i>	:	<i>Sub-Divisional Officer of the concerned Sub-Division.</i>
<i>Block Level</i>	:	<i>Block Development Officer of the concerned Block.</i>
