



## Important Update - Linkage of Aadhaar with PAN before 31st March 2021

Dear Sir,

This is to inform you that as per section 139AA of the Income-tax Act, 1961 ('Act'), every person who has been allotted a Permanent Account Number (PAN) and is eligible to obtain Aadhaar number must update his/her Aadhaar number to the Income tax department (PAN-Aadhaar Linkage).

Further, as per Rule 114AAA of the Income Tax Rules, 1962, where a person fails to intimate his/her Aadhaar number as per section 139AA (2) of the Act, the PAN of such person shall become in-operative. The rule further states that owing to the PAN becoming in-operative, it shall be deemed that he/she has not furnished, intimated or quoted the PAN, in accordance with the provisions of the Act, and the person shall be liable for all the consequences under the Act for not furnishing, intimating or quoting the PAN.

**Note: The due date for PAN-Aadhaar linkage is 31-03-2021.**

Click on the link mentioned below or paste the URL in your browser. Enter your correct PAN and Aadhaar number and submit it. It will display a status message and help you know if the PAN is linked to Aadhaar Number or not.
